## Representative Rules 2018

**As an ABSL Basketball representative a high standard of behaviour is expected at all times. Players are expected to be positive and to accept responsibility for all their actions.**

- (a) The player will abide by the laws of the country being visited.
- (b) The player will act in a manner befitting a Sporting Representative.
- (c) The player will abide by all timelines and curfews set by the Management.
- (d) The player will respect all facilities and equipment.
- (e) The player will not act, or engage in activities which interfere in the organisation of the season or with any athlete's preparation training, competition, etc.
- (f) The player shall not indulge in any pranks, jokes or other activities which endangers themselves or others.
- (g) The player shall not make any comments, or engage in any activities that are disrespectful, offensive, abusive, racist or sexist directed towards others, including, but not limited to, peers, opponents, athletes, coaches, officials, administrators, spectators and supporters.
- (h) The player may not alter accommodation arrangements made for them except with the prior written permission of the guardian AND notification to team manager. Such permission and notification is to be confirmed prior to the commencement of the trip.
- (i) The player will not leave the team or premises (training, competition, transportation, accommodations, etc.) unaccompanied for any reason. Should a guardian wish to remove a player from the team (for a meal, visit etc.), the guardian must request and receive **prior** approval and consent of Management.
- (j) The player will abide by any and all reasonable requests made by the Team Management.
- (k) The drinking of alcohol or the taking of non-prescription drugs is prohibited. Any player who in the sole opinion of the Team Management breaks this rule shall be immediately expelled from the team. All costs incurred by the ABSL in arranging for the expulsion of the player will be met by the guardian.
- (l) Any player who indulges in conduct which violates the aforementioned rules or engages in activities which amounts to serious misconduct shall, in the sole opinion of the Team Management, be subject to the following disciplinary sanctions singly or in combination:
  - Verbal reprimand, and/or a written reprimand to be placed in an individual's file;
  - Verbal apology, and/or a hand-delivered written apology;
  - Suspension from a game or a number of games;
  - Suspension from the competition;
  - Immediate expulsion from the Team;
  - Other sanctions as may be considered appropriate for the misconduct.

- (m) All costs incurred by ABSL in arranging for the expulsion of the player from the team as a result of a breach of these rules, or otherwise, will be met by the guardian.

IN the event that a player is expelled from the team, the ABSL agrees to notify the guardian immediately.

THE player and the guardian shall indemnify and hold harmless ABSL, its employees, directors, officers, sponsors, contractors, volunteers and agents from any and all claims, demands, actions and costs which may incur as a result of the athlete's failure to satisfy any provision(s) of this Agreement. This indemnification shall survive termination of this Agreement.
